We collect the following types of personal information:

- Education establishments (YoCO young people only)
- Next of kin information (YoCO young people, Volunteer Leaders only)
- Driving licence details (Trustees, Employees, YoCO Volunteer Leaders)
- Passport details (Trustees, Employees, YoCO Volunteer Leaders, YoCO young people, unsuccessful volunteer candidates)
- Police checks (DBS) (Trustees, Employees, YoCO Volunteer Leaders, unsuccessful volunteer candidates)



- References (Employees, YoCO Volunteer Leaders, unsuccessful volunteer candidates)
- Insurance information (Trustees, Employees, YoCO Volunteer Leaders)
- Attendance information (YoCO Volunteer Leaders, YoCO young people, external speakers)
- Photographs and Videos (Trustees, Employees, YoCO Volunteer Leaders, YoCO young people)
- Accident Reports (Trustees, Employees, YoCO Volunteer Leaders, YoCO young people)

## **Purposes of Data Collection**

We collect personal information in order to perform our key services, such as:

- Employee management
- Donations processing
- Volunteer management
- Young people management
- Sending newsletters
- Organising events

## **Legal Basis for Data Processing**

We process personal data under the following legal bases:

- Consent: We obtain consent for specific processing activities.
- Performance of a Contract: We process data necessary for fulfilling contracts.
- Legitimate Interest: We process data based on legitimate interests pursued by YoCO.
- Legal Requirement: We process data to comply with legal obligations.

## **Data Sharing**

We may share personal information with the following third parties:

- Enthuse
- Mailchimp
- Microsoft
- Carecheck
- Sumup

Before sharing data, we obtain consent and outline the reasons for data transfer. Before sharing data of young people and/or volunteers with any other third-party organisation, YoCO will seek consent.

We may transfer data to countries outside the UK, and we gain consent for such transfers.

## **International Transfers**

We may transfer your personal data to countries outside the UK. By engaging with our services, you consent to such transfers.

#### **Data Retention**

We retain personal data only for as long as necessary to fulfil the purposes outlined in this policy.

## **Individual Rights**

You have the right to:

- Know what data we hold on you
- Correct any inaccurate information
- Withdraw consent for specific processing
- Object to processing based on legitimate interests
- Erase data subject to our retention periods
- Obtain and use your own photographs or video images for your own purposed but not when this includes images of other individuals

## **Security Measures**

We implement security measures, including multi-factor authentication, to protect personal information from unauthorised access.

## **Cookies and Tracking**

We do not use cookies or tracking technologies on our website.

## **Children's Privacy**

We do not knowingly collect personal information from children under the age of 13.
